The enclosed scholarship application for the 2018-19 school year must be completed and submitted **no later than May 1, 2018** in order for it to be considered by the Scholarship Committee. You will be notified of the decision on your application in early July.

- [High School or College Transcript](#). If you are a high school senior, submit your 7-semester high school transcript. If you are now in college, submit your most recent college transcript.

PLEASE CONTACT US TO VERIFY WE HAVE RECEIVED YOUR TRANSCRIPT.

- [Expected Family Contribution \(EFC\)](#). We require a copy of a page showing what your EFC is from FAFSA (Free Application for Federal Student Aid). The EFC is a calculated amount that FAFSA provides. This amount can be obtained from the Student Aid Report (SAR) which you receive after you complete the FAFSA application.

Each year the Mellinger Foundation receives more applications than it has funds, so it is inevitable that a considerable number of applicants will not receive awards. Applications are reviewed by the Scholarship Committee which makes its decisions based on several criteria. The two most important criteria are financial need and academic achievement. For awarded applicants, the scholarship amount will depend upon the type of institution you attend (public, private, junior, etc.).

Remember, your completed application and two documents listed above must be in our office by May 1. Any changes should be reported to us immediately. If you have questions, please contact us.
